Continuing Education is **due 90 days before license renewal**, every two years, in the even years (2024, 2026, 2028, etc) for the State of CT

	Yearly License Expiration	CE Due On or By	Current CE Cycle
Brokers	November 30th	8/31/2026	9/1/2024 — 8/31/2026
Salespersons	May 31st	2/28/2026	3/1/2024 - 2/28/2026

#### The 12 hours of CE that are due in 2026, consist of:

- One MANDATORY course consisting of at least three (3) classroom hours in current real estate and fair housing legislation, licensing laws and regulations. ECAR is offering the "CT Real Estate License Law" Course developed by the state Education Committee and approved by DCP to specifically meet this requirement.
- Plus Nine (9) classroom hours of ELECTIVE real estate courses

## Who is Exempt from Taking CE in this Cycle?

If the date you took your licensing exam on falls within the current CE cycle, you are exempt from taking CE in the current cycle.
